This is our annual opportunity to report to you our members on the financial progress of the business and the work undertaken by the shop committee and staff to support the business. It is also an opportunity for

you, our members to ask questions or make suggestions to the committee.

This year has brought many challenges to the way we able to operate the shop, but thanks to Deb, all the staff and volunteers you can see from the financial reports that we have had one of the most successful years to date.

In March last year we entered the first a period of lockdown that required many of our customers and volunteers to isolate at home.

Overnight about 20 of our volunteers were unable to continue to offer their support to the shop. However, it is a testament to the community in which we live that a raft of new volunteers stepped forward to support us to continue to serve our community.

We all had to get used to new ways of shopping and a queue outside the shop became a familiar sight!

With the support of the Parish Council who established the Bridging the gap service we were able to support those of our customers who were unable to shop for themselves and at the peak provided around 60 deliveries each week to our most vulnerable residents through the first and all the subsequent lock down periods.

A particular thank you to Jane Colville for her drive and determination in establishing the bridging the gap services and to the many volunteers who came forward to co-ordinate the picking packing and delivering of the orders.

We would also like to thank the many new customers who visited the store at this time and chose to shop locally, following government advice to stay at home, but many of whom have stayed with us as they were impressed by the range and quality of food on offer.

We were able to benefit from some of the grant funding available to Food Retailers as part of The Covid 19 response from central government which as Maria has described we have invested back into our shop to provide a long-term benefit for our customers. This included the Provision of the outdoor shelter to provide protection from the elements while waiting to enter the store, redecoration internally. Replacement of our chilled food display and freezer as they were reaching the end of their working life and we will shortly be replacing existing the front door.
